Please note that Mr. Shailendra Mohan Gupta, Non-Executive Director of the Company has served the Company with a company petition titled “*Shailendra Mohan Gupta & Ors. v. & Ors.*” under Sections 241-242 and 244 of the Companies Act, 2013. The Company Petition has been *inter-alia* filed against JPL, Jagran Media Network Investment Private Limited (“JMNIPL”) (holding company of JPL) and other members of the Gupta Family (comprising the Promoters/Promoters Group of JPL). There is no update yet regarding the listing of this Company Petition.

Additionally, a Company Application being C.A. No. 19 of 2025 has been filed in the matter titled “*Mahendra Mohan Gupta and Ors. v. Devendra Mohan Gupta and Ors., C.P. No. 64 of 2023*” *inter-alia* impugning the resolutions passed by the majority directors in JMNIPL and appointment of an Administrator in JMNIPL. The matter is next listed on 24.09.2025 at 2:30 p.m.
